Summarized below are the activities we have completed to satisfy the \$5,000 grant award in January 2001. The \$5,000 was 25% of the requested sum for our complete proposal we submitted to the Golden Rule Foundation.

(1) We prepared a detailed cost estimate, schedule and management discussion of the 1st three years operations of an effective conservation program for Las Pozas. The effort was in response to a request from the owner's representative, Avery Danziger, and the Las Pozas legal counsel, the Texas Accountants and Layers for the Arts, Director Jane Lowery. Director Lowery determined that the estimate and write up was acceptable. The time and costs to complete this effort were 30 hours professional time and \$75 costs. The total billed to this project is \$2,475.

WE reviewed the requirements for various award grants from the Getty that we believe Las Pozas should be eligible We then prepared the agenda and conducted a meeting at the Getty Center in the Getty Conservation Institute of Los Angeles with Mr. John

Oddy, >>>>TITLE <<<< principal of the Getty >>>>?ARCHITECTURAL<<<<<<? Grant Program. The meetings were conducted and completed satisfactorily in February, March and April 2001. A detailed set of findings and open actions necessary to get awards from the Getty and other groups was documented and sent to Mr. Danziger. The open actions included responses to a set of questions posed to Mr. Danziger and Mr. Gastelum that are critical to capturing any of a set of conservation awards from the Getty Grant Program. Much of the technical responses for the Getty Grant proposal and ICCROM and other organizations have been drafted by this writer.

The time and costs to complete this effort were 25 hours professional time and \$50 costs. The total billed to this project is \$2,050.
