Second is the fact that we are even further from > being able to be > recognized as a "Historical or Cultural Monument" by > the Mexican > government. They are very willing to designate us > along those lines (at > least INBA is) BUT that would mean that all > restoration and reconstruction > plans would have to be submitted and approved by > their office prior to any

The mystery check was to cover all or part of the proposal I made to Golden Rule for a sum of about \$18,000. If it was (is) for about \$13,000 I would be hard at work for you now. Because they approved a sum of \$5,000, the difference was to cover required conservation program issues, not for the Getty, but for any grant agency. That fact is in the original proposal that SPACES administered for Golden Rule last year. SPACES may be contacted at ba559@lafn.org. As we know, the condition of Las Pozas is gradually and continually worsening.

Whatever funding you can come up with and whatever planning efforts you can do must give top priority to preserving the physical sculptures and artifacts of Las Pozas. Please follow me on this.

Many US art environments have been lost or their conditions damaged forever because the owners or supporters have been diverted from preservation of the artwork and historical artifacts. We have too many such examples. The examples almost included the Watts Towers, but they do include Bottle Village, Nit Wit Ridge and The Orange Show.

When funds are available, and at your convenience, I will provide you with a complete estimate, and priority list, to protect the most fragile, endangered structure(s) from loss. The estimate may be made from knowledge of the amount(s) of funds and dates the funds become available, if you prefer.

I am sorry we will not complete the project I had planned and also that you have not received the critical IRS and Mexican government oks.

## SITE FINANCIAL MANAGEMENT - 3 YEARS \$180,000US

A. The Financial Manager is responsible to the Las Pozas Board for assisting to establish budgets and for managing costs of the conservation program and the fund-raising program. Financial Management of \$20,000US total per year is to fund the management of the fund-raising project and all expenses of the fund-raising.

B. The Staff Curator and assistant of \$20,000US total per year will be available on site to help with tourists, typing, telephones, etc. They must keep the tourists away from wherever the work is going on and provide a presence for both site and visitor safety and cooperate with the site Conservator who will be in charge of conservation work.

## SITE CONSERVATION PROGRAM- 3 YEARS \$427,500US

A. The Chief Conservator is responsible to the Las Pozas Board of Directors for the entire conservation program for \$24,000US per year. The Chief Conservator is responsible for setting up the conservation program budget, training the conservation staff, and monitoring the budget compliance and quality of work during a series of visits and inspections. B. The Conservator is responsible to the Chief Conservator for \$26,000US per year. The Conservator is on site with the staff and acts for the Chief Conservator in budget compliance, staff training and quality controls.

C. The conservation engineer is responsible to the Conservator for engineering support as needed for \$25,000US per year D. Other professional support to the program \$13,333 per year. E. Conservation staff at \$25,000US per year. F. Maintenance staff at \$2,500US per year G. . Materials at \$8,333US per year. H. Equipment at \$10,000US per year.

I. Conservation Office supplies at \$8,333US per year.
