## \$1,500 Purse

USHER'S GREEN STRIPE MARATHON SWIM has been made possible by a contribution of \$1,500 by Messrs. Allan and Samuel Bronfman, executives of Distillers Corporation Limited. This purse is the largest ever offered for an event of this kind in aquatic sports in Montreal.

The event will be held in the St. Lawrence river (Fresh water) over a triangular course, immediately in front of the Montreal Airport Grounds, Pointe - Aux - Trembles, a distance approximately of nine miles.

Last year when George Michel won the Montreal to Sorel Marathon on September the 16th, the temperature of the water was 63. The St. Lawrence river is fresh water and during September the temperature of the water is between 60 and 70 degrees.

### QUALIFICATIONS

Marathon open to any swimmers in good physical condition from any part of the world. Doctor's certificate of good physical condition must be presented to committee during last 24 hours before race.

Entrants will be provided with an official observer, but must furnish own pilot and boat for escort. Committee will co-operate to secure boats at small cost and will provide general pilot and hospital ship.

Hotel and boarding accommodations in town or nearby cottages or camps on request at reasonable rates for swimmer entrants, trainers and families.

Each contestant must personally fill out and sign this entry form.

No entry will be recognized unless received on this form.

Any of the following costumes may be worn:— Trunks or swimming suits of any cotton, woollen, or silk material. (Suits of any other material such as cork or rubber attached or built into suits will positively be barred from the contest.)

Rubber caps and goggles will be permitted and any kind of grease or oil on the body.

Contestants taking nourishments during the swim must do so without artificial support of any kind.

Arrangements will be made by the Committee for a proper medical examination of each competitor.

No competitor will be permitted to start unless found in perfect physical fitness.

A committee formed of representatives of the Press of Montreal shall be the judges of the race and their decision shall be final as to the interpretation of the above conditions and as to any question which may arise in connection with the race. And the infraction of any of these rules or any others adopted by the Committee will cause disqualification.

The Committee reserves the right to change the date of the event.

Each contestant must furnish own boat which must be large enough to accommodate one official appointed by the Committee.

All personal expenses of contestants including attendants and supplies, shall be paid by contestant. No expense monies will be advanced to any competitor.
