AND FURTHERMORE, I CERTIFY THAT I HAVE READ THE CONDITIONS OF COMPETITION OF THE AMATEUR ATHLETIC UNION OF THE UNITED STATES, AND I AM, THEREFORE, ELIGIBLE TO RECEIVE A CARD ENTITLING ME TO COMPETE AS AN AMATEUR.

I CERTIFY THAT I HAVE TRUTHFULLY ANSWERED ALL THE ABOVE QUESTIONS. IT IS UNDERSTOOD THAT SHOULD I RECEIVE A REGISTRATION CARD IT WILL BE ON THE BASIS OF THE ABOVE ANSWERS AND ACCEPTED BY ME WITH THE DISTINCT UNDERSTANDING THAT THE REGISTRATION COMMITTEE CAN AT ANY TIME CANCEL IT.
