Sale of work

If any work is offered for sale and should be sold, CAF requests that a 15% contribution be made to CAF from that sale.

Insurance

Unless the lender expressly elects to maintain his own insurance, SBCAF will insure this work wall to wall under its fine arts policy, for the amount indicated on the loan agreement, against all risks of physical loss or damage from any external cause, while in transit or on location during the period of the loan. The policy referred to contains the usual and customary exclusions which include but are not limited to the following: loss or damage due to such causes as gradual deterioration, inherent vice, earthquake, war, invasion, hostilities, insurrection, confiscation by order of any government or public authority, risks of contraband or illegal transportation and/or trade. Work will be insured by CAF only if a completed loan form is given to the director at least one week before the opening date.

There is a \$250 deductible per work. Reasonable professional care will be exercised by CAF: however, neither the staff, Board of Directors, or members of the Exhibition Committee will be responsible for the deductible amount. If CAF determines that a work of art requires protective measures against possible damage or loss and the artist or artist's representative refuses additional precautionary measures, CAF', its staff, Board of Directors and members of its Exhibition Committee will not be held responsible for damages or loss of said artwork.

If the lender elects to maintain his own insurance, SBCAF must be supplied with a confirmation of insurance naming SBCAF as additional assured or waving subrogation against SBCAF. This loan agreement shall constitute a release of SBCAF from any liability in connection with the loaned property. SBCAF can accept no responsibility for any error or deficiency in information furnished to the lender's insurers or for lapses in coverage.
